**REQUEST**

Staff requests approval of the California Alternative Energy and Advanced Transportation Financing Authority (“CAEATFA”) Fiscal Year (FY) 2020/21 Interagency Agreement (“IA”) No. CAEATFA07-20 with the State Treasurer’s Office (“STO”) to provide executive, administrative, and information technology support to CAEATFA in the amount of \$382,841 during the term July 1, 2020, through June 30, 2021.

**SUMMARY**

**Background.** Through annual IAs, the STO provides executive, administrative, and information technology services, including, but not limited to, accounting, budgeting, legal, information technology, information security, personnel, and business services for the Boards, Commissions, and Authorities (“BCAs”) chaired by the State Treasurer. The total cost is allocated among the BCAs based on each agency’s personnel-years. The proposed IA for Fiscal Year (FY) 2020/2021 is attached as Attachment A.

Prior contract amounts for FY 2010/11 through FY 2019/20, as well as the current contemplated agreement amount, are listed below. The increase in cost for FY 2020/21 was due to the addition of three new CAEATFA staff positions.

**RESOLUTION AUTHORIZING THE EXECUTION OF AN INTERAGENCY  
AGREEMENT WITH THE STATE TREASURER'S OFFICE  
FOR EXECUTIVE AND ADMINISTRATIVE SUPPORT SERVICES**

**WHEREAS**, the California Alternative Energy and Advanced Transportation Financing Authority (the “Authority”) was created under the provisions of the California Alternative Energy and Advanced Transportation Financing Authority Act (Division 16 (commencing with Section 26000) of the California Public Resources Code) (the “Act”); and

**WHEREAS**, Section 26011(h) of the Public Resources Code authorizes the Authority to “do all things generally necessary or convenient to carry out the purposes of this division”; and

**WHEREAS**, Section 26008 of the Public Resources Code authorizes the Authority to employ an Executive Director and any other persons as are necessary to enable it to properly perform the duties imposed upon the Authority by the Act, and authorizes the Authority to delegate to the Executive Director the power to enter into contracts on its behalf; and

**WHEREAS**, the Authority wishes to enter into an Interagency Agreement with the State Treasurer’s Office for Fiscal Year 2020/2021 for executive and administrative support services, including, but not limited to, accounting, budgeting, legal, information technology, information security, personnel, and business services; and

**WHEREAS**, the State Treasurer’s Office has the ability and expertise to advise the Authority on matters pertaining to executive and administrative support services for the Authority;

**NOW, THEREFORE, BE IT RESOLVED** by the California Alternative Energy and Advanced Transportation Financing Authority the following:

Section 1. The Executive Director is hereby authorized to prepare, enter into, and execute Interagency Agreement No. CAEATFA07-20 with the State Treasurer’s Office for executive and administrative support services in an amount not to exceed \$382,841 for the term beginning July 1, 2020, through June 30, 2021.

Section 2. This resolution shall take effect immediately upon its approval.

**EXHIBIT B  
BUDGET DETAIL AND PAYMENT PROVISIONS**

**1. Invoicing**

- A. The California Alternative Energy and Advanced Transportation Financing Authority (CAEATFA) agrees to compensate the State Treasurer's Office (STO) a lump sum payment in the amount of \$382,841.00 due no later than 30 days after contract approval.
- B. Invoice shall include Agreement Number CAEATFA07-20 and shall be submitted for a one time lump sum payment to:

**2. Budget Contingency Clause**

- A. It is mutually agreed that if the Budget Act of the current year and/or any subsequent years covered under this Agreement does not appropriate sufficient funds for the program, this Agreement shall be of no further force and effect. In this event, the State shall have no liability to pay any funds whatsoever to Contractor or to furnish any other considerations under this Agreement and Contractor shall not be obligated to perform any provisions of this Agreement.
- B. If funding for any fiscal year is reduced or deleted by the Budget Act for purposes of this program, the State shall have the option to either cancel this Agreement with no liability occurring to the State, or offer an agreement amendment to Contractor to reflect the reduced amount.

**3. Payment**

- A. Costs for this Agreement shall be computed in accordance with State Administrative Manual Sections 8752 and 8752.1.
- B. Nothing herein contained shall preclude advance payments pursuant to Article 1, Chapter 3, Part 1, Division 3, Title 2 of the Government Code of the State of California.
